In Belgium, the justices of the peace (Dutch: vredegerecht, French: justice de paix, German: friedensgericht) function as the small claims courts in the country's judicial system; they stand at the bottom of the Belgian judicial hierarchy and only handle civil cases. There is a justice of the peace in each judicial canton of Belgium, of which there are 187 in total as of 2017.
