2018 Florida Statutes ... Chapter 90 EVIDENCE CODE. SECTION 902 Self-authentication. ... the court may order that they be treated as presumptively authentic without final certification or permit them in evidence by an attested summary with or without final certification. (4) ...

Chapter 90 Section 902 - 2018 Florida Statutes

According to the Florida Evidence Code, 4 there are four groups who may not be excluded from a trial or other proceeding. The first group includes a party who is a natural person. 5 Hence, in both civil and criminal matters, it is inappropriate to invoke the rule against a person who is a party to the lawsuit.

Florida Evidence. Extrinsic evidence of a prior inconsistent statement by a witness is NOT admissible unless the witness is first afforded an opportunity to explain or deny the prior statement and the opposing party is given an opportunity to question the witness on it, or the interest of justice otherwise requires.

(c) Statement against interest. — A statement which, at the time of its making, was so far contrary to the declarant's pecuniary or proprietary interest or tended to subject the declarant to liability or to render invalid a claim by the declarant against another, so that a person in the declarant's position would not have made the statement unless he or she believed it to be true.

Thus, a business record would constitute hearsay evidence since it would most likely be introduced at trial to prove the truth of the matter asserted in the record.
